

EXPLANATORY NOTES

APPLICATION TO LIFT SUSPENSION OF A DRIVER'S LICENCE OR THE RIGHT TO OBTAIN ONE (SJ-1043A)

The “Application to Lift Suspension of a Driver’s Licence or the Right to Obtain One” form is to request that a judge of the Court of Québec lift the suspension of a driver’s licence or the right to obtain one imposed as a result of:

- participation in an offence in the form of street racing or vehicle surfing;
- a repeat offence consisting in the use of a cell phone, another portable device or a display screen as provided for in the Highway Safety Code;
- offering remunerated passenger transportation by automobile without being a qualified driver or holding a driver’s licence of the appropriate class.

TYPES OF FORMS

This form is available in dynamic PDF format, meaning the form can be downloaded from www.justice.gouv.qc.ca and completed directly on screen.

- Dynamic PDF:
After completing the form, you must print it on letter-sized paper, i.e. 8.5 inches by 11 inches (215.9 mm by 279.4 mm). Be sure to set your printer to this paper size.
- Paper:
If you complete the form by hand, please write legibly in block letters.

PROCEDURE

Once the form is completed, keep a copy for your files.

You can file your application in two ways:

- At your local courthouse. You must attach the *Procès-verbal – Suspension de permis ou du droit d’en obtenir un* to your application. The clerk will assign you a file number and will indicate the date, place and time your application is to be presented before the judge, so that you can complete the “Notice of presentation” section of the form.
- Online at the Digital Court Office of Québec, which can be accessed via the website of the ministère de la Justice at www.justice.gouv.qc.ca. However, you must first contact the court office to obtain the information needed to complete the “Notice of presentation” section of the form.

You must pay a judicial fee to file your application. To find out what the costs are, refer to the website of the ministère de la Justice, at www.justice.gouv.qc.ca.

General Information

WHO MAY FILE THE APPLICATION?

This application may be filed when an inspector or a peace officer has suspended, on behalf of the Société de l'assurance automobile du Québec (SAAQ), a driver's licence or the right to obtain one for:

- 7 or 30 days because a person participated in a street race or vehicle surfing with a road or off-highway vehicle;
- 30 days because a driver reoffended (more than 2 offences in the 2 years prior to the offence) by using a cell phone, another portable device designed to send or receive information or for recreational use, or a display screen, except in the cases provided for in section 443.1 of the Highway Safety Code (HSC);
- 7 days because a person offered remunerated passenger transportation by automobile without being a qualified driver or holding a driver's licence of the appropriate class;
- 30 days because a person reoffended by offering remunerated passenger transportation by automobile without being a qualified driver or holding a driver's licence of the appropriate class;
- 90 days because of any additional offence (more than 2 offences in the 10 years prior to the suspension) related to offering remunerated passenger transportation by automobile without being a qualified driver or holding a driver's licence of the appropriate class.

WARNING

If the owner of the automobile, road or off-highway vehicle obtains the release from seizure of the vehicle from the Court of Québec further to an application for release from seizure of the vehicle under section 422.5 (street racing) or 434.6 (vehicle surfing) of the HSC or 114 of the Act respecting remunerated passenger transportation by automobile (ARRPTA), the SAAQ will automatically lift the suspension of the driver's licence or the right to obtain one without requiring that an application to lift suspension of the driver's licence or the right to obtain one be filed.

▶ HOW TO FILL OUT THIS APPLICATION

Complete the heading and indicate the facts and the conclusion of the application.
Be sure to fill out the section "Notice of Presentation", as well as the back of the form.

HEADING

- ▶ Specify the name of the judicial district where you are filing your application.
- ▶ Indicate the file number assigned by the office of the court.
- ▶ Enter the family name, given name, date of birth, address and postal code of the person who is filing the application.

FACTS *(The numbers of the explanatory notes refer to the corresponding sections of the form.)*

1. Enter the date the inspector or the peace officer suspended your driver's licence or right to obtain one, the number of your driver's licence and the number of the minutes of the suspension of the licence.
2. Indicate the reason you are applying for the lifting of the suspension of your driver's licence or right to obtain one. Check (✓) only one box and, if applicable, give the appropriate explanations on a sheet attached to the application.

CONCLUSION ("FOR THESE REASONS, I ASK")

- ▶ The object of the application is indicated in the conclusion. The Plaintiff seeks the lifting of the suspension of his or her driver's licence or right to obtain one.

NOTICE OF PRESENTATION

- ▶ The notice is to inform the Société de l'assurance automobile du Québec of the place, date and time of the presentation of the application to the judge. The court clerk will tell you the information to be provided in the notice.

SERVICE OF THE APPLICATION

- ▶ You must serve a copy of your application to lift suspension of a driver's licence or the right to obtain one, along with a copy of the minutes of the suspension of the driver's licence, on the SAAQ at least two clear days (without calculating the Saturdays and the Sundays) before the date fixed for the presentation of the application to the judge. This serve is made by bailiff. Once your application has been served, you must file the certificate of service with the office of the court two days before the date provided for the presentation, except in an emergency confirmed by the court. The application is heard and decided by preference. (When the time period is expressed in clear days, the day of receipt of the application and the day of presentation to the judge are not taken into account.)

Instead of having the application served, you can deliver a copy of it, by hand, to the SAAQ, where you will receive a signed, dated receipt marked "Copy received in lieu of service".

BACK OF THE FORM

- ▶ This section must be filled out and included with your application.
- ▶ Indicate the number assigned by the clerk to your application.
- ▶ Specify the name of the judicial district where you are filing your application.
- ▶ Enter the family name, given name, date of birth, address, postal code and phone number of the person who is presenting the application.

TO A JUDGE OF THIS COURT, THE PLAINTIFF STATES THE FOLLOWING:

FACTS:

1. On _____, an inspector or a peace officer proceeded, on behalf of the Société de l'assurance automobile du Québec, with the suspension of my driver's licence No. _____, or of any right to obtain one, for 7 or 30 days, pursuant to section 422.1, 434.2 or 443.3 of the Highway Safety Code or section 111 of the Act respecting remunerated passenger transportation by automobile, as indicated in the *Procès-verbal – Suspension de permis ou du droit d'en obtenir un* (Statement of suspension) No. _____, a copy of which is enclosed in support of the application, as exhibit P-1.
2. I am the driver of a road or off-highway vehicle whose driver's licence or right to obtain one was suspended pursuant to section 422.1 of the Highway Safety Code, and I seek the lifting of the suspension as I did not drive the vehicle in a race with another vehicle or for a wager or a stake.
 I am the driver of a road or off-highway vehicle whose driver's licence or right to obtain one was suspended pursuant to section 422.1 of the Highway Safety Code, and I seek the lifting of the suspension as I did not tolerate that a person contravene section 433 or 434 of the Highway Safety Code (vehicle surfing).
 I am a person, other than the driver, whose driver's licence or right to obtain one was suspended pursuant to section 434.2 of the Highway Safety Code, and I seek the lifting of the suspension as I was not in a situation prohibited by section 433 or 434 of the Highway Safety Code (vehicle surfing).
 I am the driver of a road or off-highway vehicle whose driver's licence or right to obtain one was suspended pursuant to section 443.3 of the Highway Safety Code, and I seek the lifting of the suspension as I did not drive the vehicle in contravention of section 443.1 of the Highway Safety Code (use of a cell phone, another portable device designed to send or receive information or for recreational use, or a display screen other than as provided for by law).
 I did not offer remunerated passenger transportation by automobile without being a qualified driver or holding a driver's licence of the appropriate class pursuant to subparagraph b of paragraph 1 of section 172 of the Act respecting remunerated passenger transportation by automobile.

FOR THESE REASONS, I ASK:

THAT the suspension of my driver's licence or right to obtain one be lifted.
