REQUEST FOR WITHDRAWAL OF COURT DEPOSIT (DRET) (SJ-366A)

The purpose of this form is to request the withdrawal of an amount of money or the securities deposited in a case. After completing the form, you must print it on letter-size paper, i.e. 8.5 inches by 11 inches (215.9 mm by 279.4 mm). Be sure to set your printer to this paper size.

- Paper:

If you complete the form by hand, please write legibly in block letters.

Once the form is completed, keep a copy for your files and send the form to the office of the courthouse in question, together with the appropriate supporting documents.
